Directions to the TURTLE LOT Marshalling Area:

From 395 take exit 79a to route 2a east. Take Exit 2 Mohegan Sun Blvd. Once you go around clover leaf at first light take a right and follow signs that say "TURTLE LOT STAGING AREA"

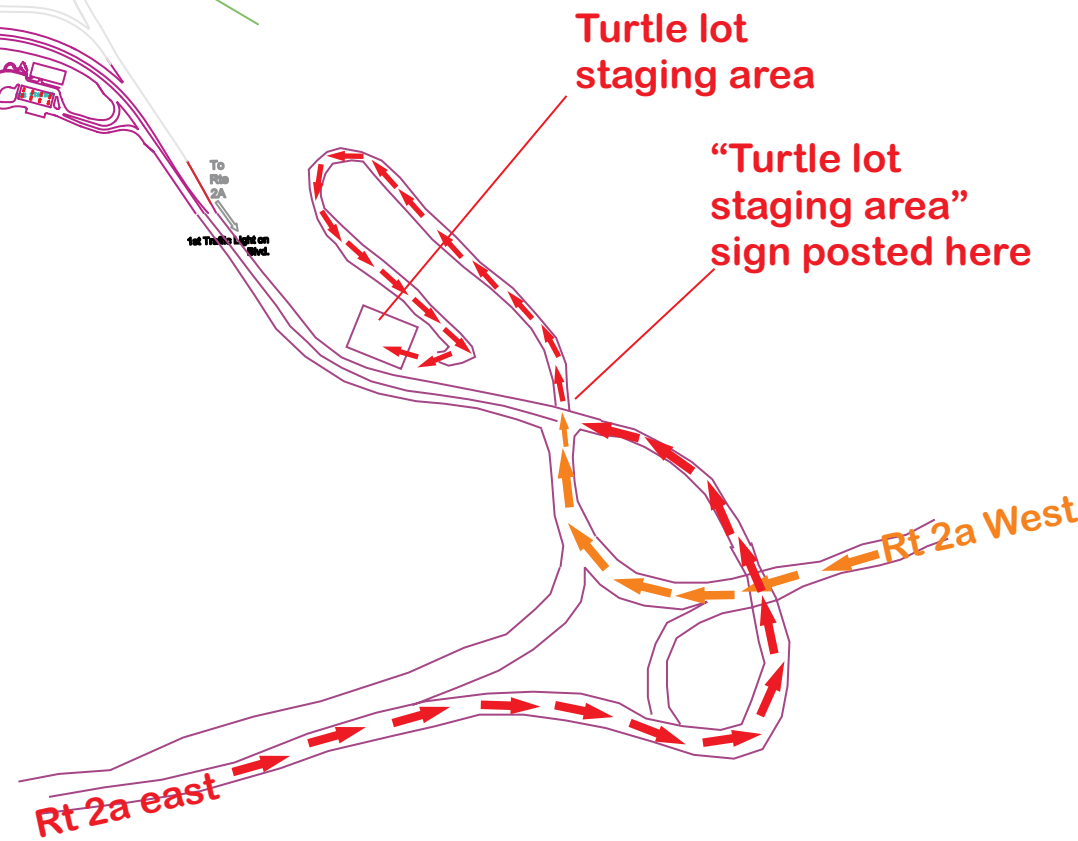
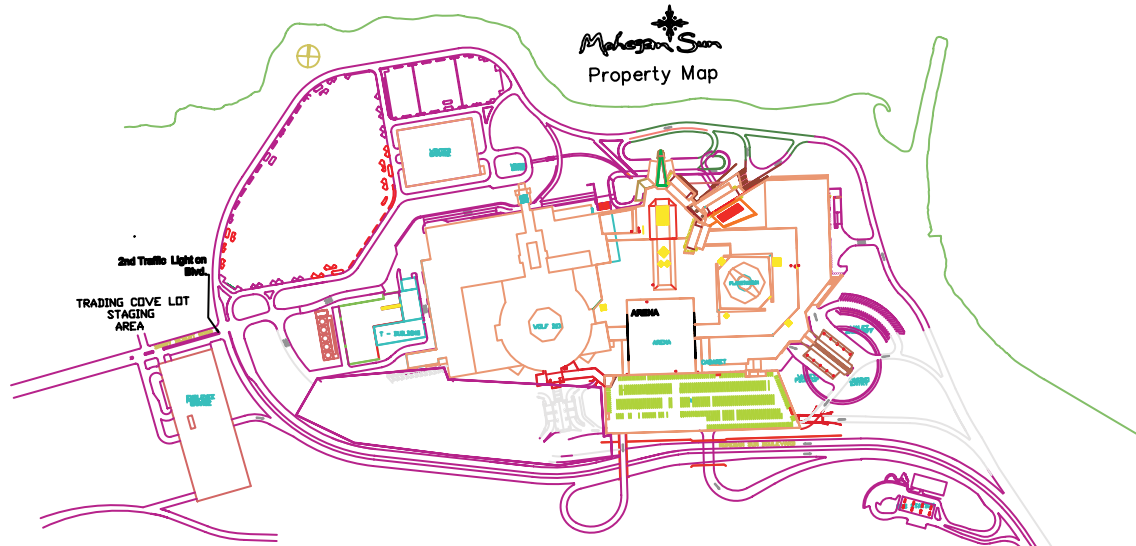
From Route 2a west bound take exit 2a Mohegan Sun Blvd. At light at Mohegan Sun Blvd stay straight and follow signs that say "TURTLE LOT STAGING AREA".

Once at Turtle Lot Staging Area: Your items will be inspected and then you will be directed to a loading dock. Once at loading dock Demers Expo will unload your display items to your booth. On the loading dock there is no loading / unloading in front of exit doors or in fire lanes. No parking is allowed on the loading dock, all vehicles must be moved immediately after loading / un-loading.

After Move In – Parking Directions

- If you are a guest of Mohegan Sun Hotel, you may park at the Hotel Valet which is located on the left after exiting the loading dock area.
- If you are not a guest of Mohegan Sun Hotel you may park at any available self parking garages or available casino valets. The closest self parking garage to the Convention Center is located at Riverview Garage. When exiting the Convention Center loading dock to the left following the street (one way) at the 3rd light make a u-turn returning back towards the resort, at the fork make a right (following the river) and the first left is Riverview Garage. Sky Valet is the second left and is also available to non hotel guests.
